



DECLARATION FOR THE PURCHASE OF FLUORINATED GASES (F-GAS)



In reference to European Regulation no. 517/2014 of 16 April 2014, Art. 6 – point 3, concerning fluorinated greenhouse gases, which requires verification that buyers of F-Gas are in possession of the relevant certifications, please to complete the questionnaire below and return it countersigned to the address indicated by us.

Art. 6 – Keeping of registers – point 3

3. For the purposes of Article 11(4), undertakings supplying fluorinated greenhouse gases shall establish registers containing relevant information relating to purchasers of fluorinated greenhouse gases, including the following details:

- (a) buyers' certificate numbers; And
- b) the respective quantities of fluorinated greenhouse gases purchased.

Companies supplying fluorinated greenhouse gases retain such records for at least five years.

Undertakings supplying fluorinated greenhouse gases shall, upon request, make those registers available to the competent authority of the Member State concerned or to the Commission. To the extent that the registers contain environmental information, Directive 2003/4/EC or Regulation (EC) No. applies, as appropriate. 1367/2006
